**EVERY PARTICIPANT IN THE SPRING BROOK STABLES DRESSAGE SCOOING SHOW SHALL CAREFULLY READ THIS NOTICE BEFORE SIGNING; NO PARTICIPANT WILL BE ALLOWED TO COMPETE WITHOUT SIGNING THIS FORM AS REQUIRED.**

Inherent risks of equine activities shall mean those dangers or conditions which are an integral part of equine activities, including, but not limited to:

1. the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and/or damage to property in their vicinity;
2. the unpredictability of an equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. the equine's response to certain hazards such as surface and subsurface objects;
4. collisions with other equines, animals, people and objects;
5. the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or to act within his or her ability.

It is hereby recognized and acknowledged that all equestrian sports involve inherent risks and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk. I am participating at my own risk and in full knowledge of the hazards and potential hazards, which are inherent in this sport.

In consideration of being allowed to participate in this event, I hereby assume all risk and inherent risks and I hereby indemnify and hold harmless Spring Brook Stables and their directors, officers, employees, volunteers, representatives and their personal representatives, from all responsibility, liability or claims of any nature and kind which I may have arising from my participation in this activity, including but not limited to bodily injury or death to myself or my horse(s) and damage to property arising from any cause whatsoever, including the negligence of one or more individuals and organizations referred to herein.
